Transferring Delivery Allocation When the Volume of Regulated Product Does Not Migrate to Another Designated Agency and the Involved Parties are Both Licensed Producers

Procedures

By the Transferor (applicant)

Complete and Submit Delivery Allocation Transfer Form

The transferor (producer relinquishing an amount of Delivery Allocation) is to complete and sign the VMC Delivery Allocation Transfer form. It is to be signed by the transferee (producer acquiring Delivery Allocation). The completed form is to be submitted to the VMC office.

By the Transferee (producer acquiring Delivery Allocation)

Complete and Submit Storage Crop Delivery Allocation Transfer Information Summary and Designated Agency Election Forms

The transferee is to complete, sign and submit to the VMC a Storage Crop Delivery Allocation Transfer Information Summary form.

Also, the transferee is to complete and submit to the VMC a signed Designated Agency Election Form. This form is to be signed by the transferee's Designated Agency of record serving to inform the VMC that it is prepared to receive an increasing amount of regulated product for marketing from the transferee.

Transfer of Delivery Allocation Application Submission Deadline

Request to Transfer Delivery Allocation applications may be submitted to the VMC at any time; however, they must be received by the VMC no later than March 15 for the transfer to have effect the ensuing crop year.

By the Transferor (applicant)

Provision of Notice by the Transferor to Their Designated Agency of Record

The transferor (producer relinquishing an amount of Delivery Allocation) is to provide notice of intention to transfer delivery allocation to their designated agency of record by no later than October 31.

Complete and Submit Delivery Allocation Transfer Form

The transferor is to complete and sign the VMC Delivery Allocation Transfer form. It is to be signed by the transferee (producer acquiring Delivery Allocation). The completed form is to be submitted to the VMC office.

By the Transferee (producer acquiring Delivery Allocation)

Complete and Submit Storage Crop Delivery Allocation Transfer Information Summary and Designated Agency Election Forms

The transferee is to complete, sign and submit to the VMC a Storage Crop Delivery Allocation Transfer Information Summary form.

Also, the transferee is to complete and submit to the VMC a signed Designated Agency Election Form. This form is to be signed by the transferee's Designated Agency of record serving to inform the VMC that it is prepared to receive an increasing amount of regulated product for marketing from the transferee.

Transfer of Delivery Allocation Application Submission Deadline

Request to Transfer Delivery Allocation applications may be submitted to the VMC at any time; however, they must be received by the VMC no later than March 15 for the transfer to have effect the ensuing crop year.

Complete and Submit an Application for a Storage Crop Producer License

As a prospective producer the transferee is to complete, sign and submit to the VMC a Producer License application. The application is to be accompanied by the requisite annual license fee.

By the Transferor (applicant)

Provision of Notice by the Transferor to Their Designated Agency of Record

The transferor (producer relinquishing an amount of Delivery Allocation) is to provide advance notice of intention to transfer delivery allocation to their designated agency of record by no later than October 31.

Complete and Submit Delivery Allocation Transfer Form

The transferor is to complete and sign the VMC Delivery Allocation Transfer form. It is to be signed by the transferee (producer acquiring Delivery Allocation). The completed form is to be submitted to the VMC office.

By the Transferee (producer acquiring Delivery Allocation)

Complete and Submit Storage Crop Delivery Allocation Transfer Information Summary and Designated Agency Election Forms

The transferee is to complete, sign and submit to the VMC a Storage Crop Delivery Allocation Transfer Information Summary form.

Also, the transferee is to complete and submit to the VMC a signed Designated Agency Election Form. This form is to be signed by the transferee's intended Designated Agency of record serving to inform the VMC that it is prepared to receive an increasing amount of regulated product for marketing and said amount from the transferee.

Complete and Submit an Application for a Storage Crop Producer License

As a prospective producer the transferee is to complete, sign and submit to the VMC a Producer License application. The application is to be accompanied by the requisite annual license fee.

Transfer of Delivery Allocation Application Submission Deadline

Request to Transfer Delivery Allocation applications may be submitted to the VMC at any time; however, they must be received by the VMC no later than March 15 for the transfer to have effect the ensuing crop year.
