### **BC PEPPER EXPORTS TO JAPAN – PROPAGATION APPLICATIONS DUE SEP. 30<sup>th</sup>**

This is a reminder that if you intend to register your propagation facility for the export program for fresh BC-grown peppers to Japan, you must submit your application (pages 1 and 2 of attached form) to the Canadian Food Inspection Agency (CFIA) by **September 30<sup>th</sup>** to this email address: WST BC Peppers / Poivrons CB (CFIA/ACIA) [CFIA.WSTBCVPeppers-PoivronsCB.ACIA@inspection.gc.ca](mailto:CFIA.WSTBCVPeppers-PoivronsCB.ACIA@inspection.gc.ca)  
Any questions can also be directed to this inbox.

**Important:** There are two application deadlines - one for propagation greenhouses and one for production and packing houses. At this time, CFIA is accepting application forms for propagation greenhouses. CFIA will send a second email in early January for a call for applications for production and packing facility applications.
