

# **B.C. Vegetable Marketing Commission**

**AMENDING ORDER # 07  
TO THE  
GENERAL ORDERS OF MARCH 16, 2005, AS AMENDED,  
MADE BY THE  
BRITISH COLUMBIA VEGETABLE MARKETING COMMISSION  
September 18, 2006**

The British Columbia Vegetable Marketing Commission General Orders of March 16 2005 as amended are further amended as follows:

1. **Part I Section 5 is amended by adding the following (inserted in alphabetic order):**

**“Family Unit” means an associated group of registered Producers operating with common ownership and management.**

2. **Part XVII Section 6 is deleted and the following substituted therefore:**

**“After one round (100 percent) of all Delivery Allocations has been shipped for any Storage Crop or Field Crop in any Delivery Allocation period, Delivery Allocations shall be awarded equally to each registered Producer. For the purposes of this Section registered Producers operating as a Family Unit may be grouped together and in those instances the Family Unit will receive the Delivery Allocation of only one registered Producer.”**

3. **Part XVII Section 8 is deleted and Sections 9 through 12 are renumbered as Sections 8 through 11 respectively.**

4. **Part XVII Section 13 is deleted and Sections 14 through 18 are renumbered as Sections 12 through 16 respectively.**

5. **Part XVII Section 16 is deleted and the following substituted therefore:**

**16: Delivery Allocation periods for the Storage and Field Crops are as follows:**

**NON-COUNT SIZE FRESH RUSSET POTATOES, and  
NON-COUNT SIZE FRESH “ALL OTHER” POTATOES, and  
COUNT SIZE RUSSET POTATOES**

"A" Period Start of new crop to July 31<sup>st</sup>  
"B" Period August 1<sup>st</sup> to Sept. 30<sup>th</sup>  
"C" Period October 1<sup>st</sup> to January 31<sup>st</sup>  
"D" Period February 1<sup>st</sup> to end of old crop

**FOOD SERVICE POTATOES**

Period 1 August 1<sup>st</sup> to September 30<sup>th</sup>  
Period 2 October 1<sup>st</sup> to April 30<sup>th</sup>  
Period 3 May 1<sup>st</sup> to July 31<sup>st</sup>

**RUTABAGAS**

"A" Period Commencement of crop to July 15<sup>th</sup>  
"B" Period July 16<sup>th</sup> to August 31<sup>st</sup>  
"C" Period Sept. 1<sup>st</sup> onward

**BEETS; CABBAGE; CARROTS; ONIONS; PARSNIPS; WHITE  
TURNIPS; LETTUCE; and CELERY  
Monthly**

**6. Items 1, 2, 3 and 4 come into effect on September 18, 2006, and apply to Period B for Fresh Potatoes, Period 1 for Food Service Potatoes, Period B for Rutabagas and September 1 for all other crops.**

**7. Item 5 comes into effect on September 18 2006 and applies to the 2007/2008 crop year.**
