MESSAGE FROM DEREK STURKO, CHAIR BCVMC

As we approach the end of 2024, it's a good time to outline a few of the BCVMC's objectives for the year ahead.

One major objective is completing the modernization of the General Order to make it easier for industry to understand. Recently, the Commission rewrote the Order, re-introduced the Agency Order, and incorporated select elements from the policies listed on our website (all of which will be rescinded). We have circulated the revised General Order for feedback, with comments due by December 31, 2024. The final step in the process will be to address a few critical matters (e.g.: streamlining the licensing process) using a short-term Task Force with representation from the greenhouse and storage crop sectors. This foundational work is essential to the Commission's broader mandate and activities.

Another objective for 2025 is the formal introduction of agency reviews. These reviews began this year through a staff-led process to monitor the activities and progress of three agencies in response to identified areas of concern. Next year, the Commission will focus on completing the reviews of these agencies, and taking any necessary action(s).

A third objective for 2025 is our commitment to improving communications, transparency, and engagement. To achieve this, we plan to:

- · Strengthen engagement with smaller agencies and growers to ensure their perspectives are heard.
- Ensure decision-making processes are timely, transparent, and well-documented.
- · Provide regular updates through enhanced communication tools.
- · Redesign the BCVMC website to improve navigation and the user experience.

I encourage you to stay informed on these and other priorities in the coming year. In the meantime, on behalf of all BCVMC commissioners and staff, we wish you all the best for the holiday season.

BCVMC Election

The 2025 Election will be conducted in the upcoming months. The BCVMC will need to fill two (2) postions for elected members of the BC Vegetable Marketing Commission (BCVMC). The two elected positions consist of one member for the Greenhouse Crop category and one member for the Storage Crop category.

BCVMC Independent Member Appointments

In 2025 the BCVMC will need to appoint two (2) independent members to the Commission. A Selection Committee will establish an Appointment Schedule and will manage the process. The process will commence in January 2025.
